Notification

NO.COE-1(P&D) 1-3-94 in exercise of the powers conferred by section 25 of Cholistan Development Authority Act – 1976 (XIV) of 1976 the Governor of the Punjab is pleased to make the following Rules namely:-

1. i). These Rules may be called the Cholistan Development Authority (Delegation of Powers) Rules 1995.
2. ii). Notwithstanding any provisions to the contrary contained in any service rules for the time being in force in the province or any part thereof, the punishment in respect of each person holding a post in Cholistan Development Authority as mentioned in the Column No. 2 of the Schedule annexed here-to shall be such as are specified against the post of such person in column 3 to 6 of the said Scheduled.
ii). That the authority empowered under these rules to impose penalties on the holder of post shall be competent to impose such penalties on every persons holding such posts whether such person was appointed by such Authority.
